DISCUSSION PAPER ON THE UIP CONSTITUTION


The UIP Constitutional Reform Committee and the UIP Executive Committee have been involved in a comprehensive review of the Constitution of the UIP, identifying potential areas for discussion and review. Legal opinion has been sought from two independent law firms, both of which have advised that the UIP Constitution is not legally compliant and is a historic document of no legal standing.

The process of consultation of UIP societies began in 2021, with a series of online General Council webinars aimed at introducing these topics to the General Council and collecting preliminary feedback. From these discussions, the UIP has compiled a Discussion Paper, the purpose of which is to canvas the issues by providing a framework and providing arguments for and against any proposed change.



IN MEMORIAM

Prof Dr Never Rosli



Prof. Dr. Never Rosli, (1940/2022), born in Santa Fe, graduated as a doctor in Córdoba, began his career in Phlebology guided by Professors Saúl Umansky and César F. Sánchez.

In Córdoba, he was the founder of a Phlebological Center, which was perhaps the most advanced in Latin America at thay time. Furthermore, he was a founding member of the Society of Phlebology and Lymphology of Córdoba and President.

In 1992, he was the President of the SAFYL of Phlebology (Argentine Society Lymphology) at a national level. At a Latin American level, he was Honorary President of the

Pan American Society of Phlebology Lymphology.

In 2001, he became the Vice President of the International Union of Phlebology (UIP) and, later in 2007, an Honorary Member.

He participated as co-author in several books. Moreover, in 1976, he was the author of the book "Varices. Sclerotherapy. Practical Phlebology", with a foreword by Prof. E. Altman Canestri; at the beginning, the book was attacked by surgeons at all costs due to its sclerotherapy concepts. Nowadays, this books is still a compulsory resource in postgraduate courses.

Prof. Dr. Never Rosli was the first to consider sclerotherapy an art rather than a usual medical technique, a concept that other authors expanded and presented over the years.

In the 90s, he began his search for the truth in sclerotherapy. Having achieved objective, he presented this technique with other colleagues in a scientific conference at the Argentine Medical Association (AMA), during which he presented cases of giant varicose veins and venous aneurysms treated with this method.

We cannot fail to mention that Prof Dr Never Rosli organized sclerotherapy hierarchically and valued it at the same level as surgery and microsurgery, with the achievement of equal or better medical and aesthetic results obtained with less aggression, sequelae and costs. .

For more than 50 years, he attended and actively participated in the monthly scientific meetings of the Society (SAFyL) and in numerous national and international events, in addition to being the dinners ineffable entertainer of of our phlebological bohemia that we will not forget.

UIP EDUCATION MODULES

The UIP is proud and excited to introduce online phlebology educational modules to improve and standardise education and training in phlebology across the globe.

The education modules are designed to provide a basic and standardised understanding of various aspects of phlebology. The modules provide a structured and focused learning system to better prepare trainees for fellowship or similar examinations in venous disease.

The online module system was developed as part of the Australasian College of Phlebology (ACP) training program under the auspices of the UIP. Each module covers a topic that is managed by an instructor who is an expert in the field. There is a total of 60 modules divided into:

- Venous Interventions 1

Advanced—Year 3

- Pelvic Venous Insufficiency
- Venous Interventions 3
- Vascular Dermatology and Vascular Anomalies 1

- **Basic Sciences 2**
- Venous Interventions 2
- Venous Thromboembolism
- Conservative Management

Fellowship—Year 4

- Venous Obstruction
- Venous Interventions 4
- Vascular Dermatology and Vascular **Anomalies 2**

Subscription to the modules is for one-year access to all modules within the system.

UIP registrants can determine at which pace they would like to continue through the program. Should you need more time to work through the modules you will need to subscribe for another year of access to the online modular system.

Your one-year subscription will also provide you with access to the Royal Society of Medicine (RSM) online library which will assist you in completing your online modules. The RSM online library access is included in your module subscription fee (not included free registrations from tier 2 and 3 countries or for individual courses).

Mexican Society of Angiology, Vascular & Endovascular Surgery



Our organization was founded on September 29. 1959 under the "Sociedad name of Mexicana de Angiología" (Mexican Society of Angiology). Later, it would be called "Sociedad Mexicana de

Angiología Cirugía Vascular Endovascular" (SMACVE—Mexican Society of Angiology, Vascular & Endovascular Surgery).

The first president was Dr Héctor Quijano Méndez, in the period 1960-1962. Since then, a total of 32 presidents have led the SMACVE.

Currently, the president is Dr. Carlos Arturo Hinojosa Becerril, who leads the Society in the period 2021-2022. The SMACVE is made up of 422 active members and vascular surgeons in Mexico.



Our mission is the development of academic activities and research on topics related to Mexican vascular surgery, as well as the constant of research in vascular endovascular surgery performed in different institutions in Mexico.

The vision of our Society is to consolidate as a group in order to study, develop, research, promote and distribute topics related to venous, lymphatic, arterial, vascular access and diabetic foot pathology.

The main objectives are:

- To play a scientific and educational role in favor of its members, thanks to the integration of standards of practice.
- To promote dissemination and updating supported by courses and publications.
- To propose the necessary changes and adjustments to the postgraduate programs related to our specialties in order to keep them up to date.
- To facilitate the exchange of experiences and scientific information among its members by means of national and international activities or through its publications.

In 1973, the journal Revista Mexicana de Angiología was officially founded, created and directed by Dr Nicolás Figueras Carrera. This journal has a national and international distribution, and currently its chief editor is Dr Javier Eduardo Anaya Ayala. The publication is available in several databases that can be accessed from anywhere in the world.

Each month, the UIP invites one Member Society to provide a brief summary of its past, present and future activities to be included in the newsletter. This month, the Thai Venous Forum / Thai Vascular Association has provided an article.

In addition, a SMACVE newsletter is issued quarterly and, just in December 2021, its tenth edition was published, coordinated by Dr Sandra Olivares Cruz.

In October 2021, the LIII Annual International Congress of Angiology and Vascular and Endovascular Surgery was successfully held, which brought together a large number of angiologists and surgeons of different nationalities who reviewed and discussed current topics related to angiology. Similarly, in September 2021, the XIII Annual Joint Meeting of University Programs in Vascular and Endovascular Topics was held. These two summit activities are in addition to the multiple regional vascular congresses held throughout the country. We have established weekly meetings and academic sessions among all the Angiology residents of Mexico to achieve the homogenization of contents. The SMACVE has sought to reach medical students by

organizing an annual symposium for them, which has free access, in order to achieve a deep approach to Angiology, which during the career may be limited.

In 2021, the last book issued by the SMACVE was published, entitled "Venous Pathology", which is part of the academic collection of the institution, and can be consulted at the following http://www.incmnsz.mx/ link:

Moreover, we have worked together with other Mexican and international societies with which have consolidated important we an interdisciplinary relationship, which facilitates communication and discussion of the issues that concern us, as well as the publication of articles and scientific research.

Likewise. the Youna Vascular Surgeons Committee was created, which is part of the Society, and its purpose is to facilitate the integral professional development, supported in the search for projects focused on techniques and ideas that allow innovation and continuous renovation.

The SMACVE is directly involved in generation and updating of the Mexican Clinical Practice Guidelines on Angiology and Vascular Surgery. In addition, topics of relevance to the population have been disseminated in different local and national newspapers.

In the last decade, and due to the multiple efforts of its directors and members, the Society has grown exponentially in terms of members, publications, meetings and dissemination, which has allowed it to consolidate as the best of its kind in Mexico.

Decreased mobility, lack of social support, haemosiderosis and use of antidepressant medications may predict recurrent venous leg ulcers within 12 months of healing: A prospective longitudinal study

Abstract Aim

To identify clinical, medical and psychosocial predictors of venous leg ulcer recurrence within 12 months of healing.

Methods

A multi-site study was conducted in Australia in community and hospital outpatient settings. Adults with venous leg ulcers were recruited within 4 weeks of healing and data were collected on preventative treatments and health, medical, clinical and psychosocial factors. Follow-up data on recurrences were collected every 3 months until ulcer recurrence, or until 12 months after healing pending which occurred first. Factors associated with time to recurrence were analysed using a Cox proportional hazards regression model.

Design

Secondary data analysis of a multi-site, prospective longitudinal study to validate a risk assessment tool for recurrence.

Results

A sample of 143 participants was recruited (51% male, Mage = 73 years, SD 13.6). Almost half (49.6%) had an ulcer recurrence within 12 months, with a mean time to ulcer recurrence of 37 weeks (SE 1.63, 95% CI 33.7–40.1). Factors measured at the time of healing that were significant independent predictors of recurrence were: prescribed antidepressant medications (p = .035), presence of haemosiderosis (p = .006), decreased mobility (longer sitting times) (p = .007) and lower social support scale scores (p = .002). Participants who wore compression systems providing 20 mmHg or higher for at least 5 days/week were less likely to recur, although not reaching statistical significance (p = .06).

Conclusion

Results provide evidence that antidepressant medications, haemosiderosis, decreased mobility and lack of social support are risk factors associated with ulcer recurrence; therefore, these variables are modifiable and could guide early intervention.

A systematic review of current trends in pharmacologic management after stent placement in nonthrombotic iliac vein lesions

Abstract

Objective

Stenting of the iliac vein is increasingly recognized as a treatment for chronic venous insufficiency (CVI). However, the pharmacologic management after stent placement is unclear. This review was conducted to illustrate recent trends in anticoagulation and antiplatelet regimens following stent placement for nonthrombotic iliac vein lesions (NIVL).

Methods

The MEDLINE database was searched using the term "iliac vein stent." Retrieval of articles was limited to studies conducted on humans and published in English between 2010 and 2020. Studies were included that described iliac vein stent placement. Studies were excluded that contained fewer than 25 patients, performed procedures other than stent placement, did not specify the postoperative anticoagulant used, or treated lesions of thrombotic origin.

Results

12 articles were included in this review, yielding a total of 2782 patients with a male-to-female ratio of 0.77. The predominant CEAP classification encountered was C3. The most common stent used in the included studies was the Wallstent (9/12), and the most common pharmacologic regimen was 3 months of clopidogrel (6/12). Warfarin, aspirin, cilostazol, and rivaroxaban were among other agents used. Primary stent patency ranged from 63.1 to 98.3%. There was no apparent correlation between pharmacologic agent used and stent patency or subjective patient outcomes.

Conclusion

Multiple different approaches are being taken to pharmacologically manage patients following stent placement for NIVL. There is no consensus on which agent is best, nor is there a formal algorithmic approach for making this decision. Additionally, the findings in this study call into question whether anticoagulation following stenting for NIVL is necessary at all, given the similar outcomes among the different agents utilized. This review underscores the potential value of undertaking a multiinstitutional prospective study to determine what is the best pharmacologic therapy following venous stent placement for NIVL.
